ANNOUNCEMENT

The announcement is made pursuant to the Inside Information Provisions under Part XIVA of the SFO and Rule 13.09 (2) of the Listing Rules by the Company.

The Board hereby announces that Jiangbei Machinery, a wholly-owned subsidiary of the Company, won the bid for the land use right of Plot No. Q10-1/01 of Standard Sub-zone Q at Yuzui Zutuan, Liangjiang New Area, Chongqing City with an area of approximately 109,678 square meters (approximately 164.5 Mu), a parcel of state-owned construction land, by way of bidding invitation, auction and listing (招拍掛), for the environmental relocation project of Jiangbei Machinery.

Reference is made to the announcement of the Company dated 5 February 2013 in respect of the environmental relocation project of Jiangbei Machinery. An aggregate amount of approximately RMB256.07 million was invested in phase I of the project which mainly involved land acquisitions, construction planning and design, construction of buildings, implementation of ancillary facilities and purchase of equipment, CNC renovation, etc. before completion of the environmental relocation and resumption of production.

Jiangbei Machinery won the bid for the land use right of Plot No. Q10-1/01 of Standard Sub-zone Q at Yuzui Zutuan, Liangjiang New Area, Chongqing City with an area of approximately 109,678 square meters (approximately 164.5 Mu), a parcel of state-owned construction land, at approximately RMB307 per square meter (totaling RMB33.63 million) in the listing-for-sale activity held at 99 Renhe Street, Yuzhong District, Chongqing City on 25 November 2013 for the land use right of the state-owned construction land parcel. Jiangbei Machinery received Sales Confirmation Letter for the Land Use Right of State-owned Construction Land (Yu Di Jiao Yi Gong[2013] No. 105) (國有建設用地使用權成交確認書(渝地交易工[2013]105號)) dated 28 November 2013 issued by Chongqing Land and Mining Rights Transaction Centre (重慶市土地和礦業權交易中心) on 29 November 2013. The land parcel will be used for the environmental relocation project of Jiangbei Machinery.

At present, the environmental relocation project of Jiangbei Machinery is being carried forward as planned.
