The top 5 shareholders of SWSC are Chongqing Yufu Assets Management Group Co., Ltd (重慶渝富資產經營管理集團有限公司), Chongqing Jiangbeizui Central Business District Investment Group Co., Ltd. (重慶市江北嘴中央商務區投資集團有限公司), China Jianyin Investment Ltd. (中國建銀投資有限責任公司), Chongqing City Construction Investment Group Co., Ltd. (重慶市城市建設投資(集團)有限公司) and Chongqing Expressway Group Co., Ltd. (重慶高速公路集團有限公司), holding 26.99%, 7.09%, 5.82%, 5.41% and 5.31% of the equity interest in SWSC respectively. All the said 5 shareholders are state-owned enterprises.
